CONSIGNMENT CONTRACT

1. Consignor agrees to consign the merchandise listed on the attached "List of Items Being Consigned". Consignor represents and warrants that it is the lawful owner of the merchandise, that the merchandise is free from all encumbrances. Consignor has the right to sell the merchandise, and Consignor will warrant and defend, at their sole expense, the sales of the merchandise against the lawful claims of any and all persons, entities, or estates.
2. Merchandise will be offered for sale at the initial selling price as set forth in this contract. This contract is based on a 120-day period. After 90 days items will be marked down 20% to 30%. If the Consignor does not wish further reductions after 90 days they have the right to pick up any remaining items within 48 hours. At all times, we reserve the right to sell merchandise to authorized Dealers and Designers at the trade discount of 20%.
3. If the item(s) have not sold after 120 days, the Consignor may pick the item(s) up, or have them donated to charity and a tax receipt will be sent to them. No donation slip will be sent for any items valued at less than \$100, based on the final sales price. In the event the Consignor fails to remove merchandise within 72 hours of the end of the contract, Consignor shall be considered to have abandoned the merchandise, and it becomes the sole property of Antique Row Consignments.
4. Consignor receives 50% of actual selling price, less any pick up charges if applicable. Checks are issued after the 20th of the month for all sales in the previous month. Consignors picking up items within the first 90 days of the contract will result in a charge of 25% of the original listing price, plus pick up fee if applicable.
5. We can arrange pick up of your items if needed. This is a contracted service between you and the movers. They carry their own liability insurance.
6. We reserve the right to reject any item for consignment, and require that all items be in good condition, clean, stain and odor free, with no tears, missing or broken parts. If the item brought in for consignment is found to have previously unknown defects, which renders it unsuitable for sale, the customer must pick the item up or have it donated, and pay any applicable pick up fees.
7. The selling price shall be consistent with similar items if applicable. We will make every effort to price the items according to your wishes, however we reserve the right to price all items.
8. We will make every effort to protect the safety and condition of your merchandise. However, we are not responsible for or liable for theft, damage, or any type of casualty loss for the items consigned. Please check with your insurance company for extended coverage if desired.
